- In addition to above the Managing Committee shall abide by the provisions of Haryana School Education Rules, 2003 and amendments if any thereafer. The Managing Committee shall be liable for disciplinary action in case of violation of any provisions of the rules. 15.
- School will provide ramp within six months.
